The Summer Youth Theatre Program operates for 6 weeks during the months of July and August.

Assistant Stage Directors of the theatre education summer program at Oshawa Little Theatre will plan, prepare for, create and organize all daily activities and rehearsals for the youth participants of our summer theatre education program, which operates over three two-week sessions. The Assistant Stage Directors will work with other staff and enrolled participants, engaging in theatrical activities and educational experience that inspire and develop latent performance skills in the youth participants. Assistant Stage Directors will assist in the recruitment of youth for the program and will ensure the safety, security and occupation of participants at all times. Additionally, the Assistant Stage Directors will ensure that all participants and guardians conform to current and healthy safety guidelines while on site.

Oshawa Little Theatre provides education and mentorship opportunities to children and youth through performance and technical theatre programs, which operate year-round. Oshawa Little Theatre provides volunteer and educational opportunities for interested parties of all ages in all areas of theatre development. Oshawa Little Theatre's educational programming supports youth in our community. We provide theatrical training and employment opportunities without bias and welcome those who self-identify as disabled, minority, special needs and LGBTQ2+. We are officially recognized within our community as a leader in youth programming and support.

Qualifications

This job is part of the Canada Summer Jobs Program. As per the requirements of the program, candidates need to meet the following criteria. Please ensure you review the below before applying:

- Be between 15 and 30 years of age at the start of the employment;
- Be a Canadian citizen, permanent resident, or person to whom refugee protection has been conferred under the Immigration and Refugee Protection Act for the duration of the employment;
- Have a valid Social Insurance Number at the start of employment and be legally entitled to work in Canada in accordance with relevant provincial or territorial legislation and regulations;
- The candidate must be 15 years of age at the beginning of the employment period. The youth may be more than 30 years of age at the end of the employment period, as long as the youth was 30 at the beginning of the employment period;
- International students are not eligible participants. International students include anyone who is temporarily in Canada for studies and who is not a Canadian citizen, permanent resident, or person who has been granted refugee status in Canada. Youth awaiting a refugee status ruling, as well as those who hold a temporary visitor visa, youth visa or work visa are ineligible. As the objective of the Canada Summer Jobs program is to support youth entering the Canadian labour market, the temporary nature of an international student's time in Canada does not allow for a long-term connection to the labour market.
