The Stage Technician (Technical Director) of the theatre education summer program at Oshawa Little Theatre will plan, prepare for, create and organize the sets, sound, costumes, props, lighting, effects and other technical details of our summer theatre education program, which operates over three two-week sessions. The Stage Technician will work with other staff and enrolled participants, engaging in theatrical activities and educational experience that inspire and develop latent technical skills in the youth participants. The Stage Technician will ensure the safety, security and occupation of participants at all times. Additionally, the Stage Technician will ensure that all participants and guardians conform to current and healthy safety guidelines while on site.

Oshawa Little Theatre provides volunteer and educational opportunities for interested parties of all ages in all areas of theatre development. ## Qualifications

This job is part of the Canada Summer Jobs Program. As per the requirements of the program, candidates need to meet the following criteria. Please ensure you review the below before applying:

- Be between 15 and 30 years of age at the start of the employment;
- Be a Canadian citizen, permanent resident, or person to whom refugee protection has been conferred under the Immigration and Refugee Protection Act for the duration of the employment;
- Have a valid Social Insurance Number at the start of employment and be legally entitled to work in Canada in accordance with relevant provincial or territorial legislation and regulations;
- The candidate must be 15 years of age at the beginning of the employment period. The youth may be more than 30 years of age at the end of the employment period, as long as the youth was 30 at the beginning of the employment period;
- International students are not eligible participants. International students include anyone who is temporarily in Canada for studies and who is not a Canadian citizen, permanent resident, or person who has been granted refugee status in Canada. Youth awaiting a refugee status ruling, as well as those who hold a temporary visitor visa, youth visa or work visa are ineligible. As the objective of the Canada Summer Jobs program is to support youth entering the Canadian labour market, the temporary nature of an international student's time in Canada does not allow for a long-term connection to the labour market.
